The Liverpool Fire Department is hiring firefighter/EMTs part time to fill positions daily.

Includes:

- 2 staff members daily
- 24 and 12 hour shifts
- Hourly wages
- Up to 30 hours a week

Distinguishing features of the class: The work involves responsibility for the combined functions of preventing, controlling and suppression of fires, performing rescue operations, and providing emergency medical services to residents of the response district of the Liverpool Fire Department. Responsible for maintaining the cleanliness and functionality of a fire station, including fire equipment, vehicles, and the building itself, ensuring everything is ready for immediate use in case of an emergency; this typically involves cleaning apparatus, performing minor repairs, checking fuel levels, and monitoring the station for safety issues while on shift. Able to drive fire apparatus if needed. Does related work as required. Minimum of 36 hours of employment per calendar quarter.

Open competitive qualifications:

- Must be twenty one (21) years of age.
- Must be a citizen of the United States.
- Must possess and maintain a current certification from the New York State Department of Health as an Emergency Medical Technician or higher.
- Be registered with CNYEMS and have a valid EMT certification in good standing with the state and region.
- Must possess and maintain a valid NYS Driver's License.
- Ability to pass a criminal background check and driver record check.
- Must be a Full Time Firefighter currently hired in a career or combination fire department / district with a minimum of 1 years experience
- Candidates must meet the requirements for basic and in-service fire training programs and additional administrative procedures for the municipal training program found in 19 NYCRR Part 426 Minimum Standards for Firefighting Personnel in the State of New York and 19 NYCRR Part 427 Minimum Standards for Firefighting personnel, Administrative Procedures. (NYS Professional Firefighter Certification)
- Must not be an ACTIVE member of the Liverpool Fire Department
